of Silverton, ,State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Silver Creek a tributary of Pudding River for the purpose of Irrigation under Permit No. 1541 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NENK, NKNK, SENK, Section 2, Township 7 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.3 acres in the NE4 NW4, as projected on John Barger D.L.C.
- 0.7 acres in the NW4 NW4, as projected on John Barger D.L.C.
- 0.5 acres in the SE Nu , as projected on John Berger D.L.C. Section 2
- T. 7 S., R. 1 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning 1.59 chains North 42° East from the Southeast corner of a tract of land deeded to Mrs. L. V. Matheny on the 10th day of October, 1914 which deed is recorded on page 126 in Volume 134, of Marion County Deeds records; thence North 42° East 2.74 chains to the center of Silver Creek; thence South 46° 18' East up said creek 9.51 chains; thence South 54° 49' West 3.40 chains; thence North 46° 18' West 8.76 chains to the place of beginning; being situated in Section 2, in township 7 South, Range 1 West of Willamette Meridian, in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
