## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That R. STADELI

of Route 3, Silverton State of , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed stream and spring

a tributary of Brush Creek, a tributary of Pudding River

for the purpose of

Pomestic, stock, turkeys, and ram under Permit No. 15444 of the S of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Merch 17, 1943 for 0.02 cubic foot per second,

Merch 20, 1943 for 0.04 cubic foot per second,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second, being 0.01 cubic foot per second for domestic, 0.01 cubic foot per second for stock and turkeys, and 0.04 cubic foot per second for ram, also being 0.01 cubic foot per second from spring for domestic, stock and turkeys and 0.05 cubic foot per second from stream for domestic, turkeys and ram,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA NWA, SLA NWA & NWA SWA as projected on Christ F. Mascher D.L.C., Section 10, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - - of one cubic foot per second per acre,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
