## CERTIFICATE OF WATER RIGHT

This Is to Certify, That Molalla Flax Growers, inc.

of Canby , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Molalla River

a tributary of Manufacturing for the purpose of

under Permit No. 15447 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 25, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.11 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 1 (SW NW4) Section 20, Township 4 South, Range 2 East, W. M.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
