CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL SCHERFF

of Route 2, Oregon City, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed stream a tributary of Clackamas River for the purpose of Irrigation under Permit No. 15451 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 4, Township 3 South, Range 3 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.3 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
0.2 acre in Lot 3 (NE $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 4
T. 3 S., R. 3 E., W.M.

Land on which water is to be used is a part of the property more explicitly described by proprietor as follows:

Part of the Northeast quarter of the Southwest quarter and part of Government lot 3, in Section 4, T. 3 S. R. 3 E. of W. M., described as: Beginning at a basalt stone set at the southwest corner of the northeast quarter of the southwest quarter of section 4, T. 3 S. R. 3 E. W.M., running thence North tracing the west boundary of the northeast quarter of the Southwest quarter of said Section 1077.62 feet to a point in the center of Market Road No. 8, said County; thence tracing the center of said road S. 52° 24' E. 892.97 feet to a point of curve; thence tracing the center of said road on a 20° curve to the left, through a central angle of 47° 12' a distance of 339.00 feet to a point of tangent; thence tracing the center of said road N. 79° 48' E. 644.25 feet to the most Northerly corner of a tract of land conveyed to Roy Clifford Smith by deed recorded in book 201 at page 263, record of deeds of Clackamas County; thence tracing the northwesterly boundary of said tract, S. 71° 45' W. 277.00 feet to an iron pipe; thence tracing the westerly boundary of said tract S. 12° 14' E. 367.00 feet to a stake driven at a corner of said tract; thence S. 49° 00' W. tracing the northwesterly boundary of said tract 197.00 feet to an iron pipe driven in the South boundary of the northeast quarter of the Southwest Quarter of said Section 4, said township and range; thence tracing the South boundary of the northeast quarter of the Southwest quarter of said Section S. 89° 12' W. 1233.20 feet to the place of beginning, containing 21.16 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
