CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWIN WEIDMAN

State of of Route 2, Molalla , State of Oragon , has made proof to the satisfaction of the STATE ENGINEER of Oragon, of a right to the use of the waters of , has made proof Unnamed stream a tributary of Molalla River

for the purpose of

Irrigation under Permit No. 15490 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NUNE), Section 24, Township 5 South, Range 2 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 0.2 acre in Lot 1 (NWANEL) Section 24 T. 5 S., R. 2 E., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a stone monument at the Southwest corner of Government Lot 1 in Section 24, Township 5 South, Range 2 East, of the Willamette Meridian; thence East 1031.35 feet along the South boundary of said Government Lot 1 to a point 87.30 feet West of the Southeast corner of said Government Lot 1; thence North CO 34' East 768.7 feet on a line parallel to the East boundary of said Government Lot 1 to a point in the center line of County Road No. 1137 at Engineers Station: 53+50.50; thence Westerly along the center line of said County Road No. 1127 a distance of 809.0 feet to Engineers Station 61+59.50 which point is the Southwest corner of that certain tract of land conveyed to Ambrose Strocker by deed recorded in Book 174 on Page 250 Record of Deeds for Clackamas County, Oregon; thence North 1478.5 feet to a point in the North boundary of the South one-half of the Southeast one-quarter of Section 13, Township 5 South, Range 2 Fast, of the Willamette Meridian; thence North 89° 26' West 1332.05 feet to the Northwest corner of Government Lot 4 in soid Section 13; thence South 19° 31' East 2786.90 feet following the Westerly boundary of said Government Lot 4 and said Government Lot 1 to the place of beginning. Containing 70 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
