**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      RALPH I. GIFFORD

of Route 4, Box 343, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pringle Creek a tributary of Willamette River for the purpose of Irrigation under Permit No. 15366 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 9, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0125 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 3, Township 8 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in the SE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 3  
T. 8 S., R. 3 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the Northwest corner of Lot Numbered One (1) of Block Numbered Two (2) of Oak Hill Tracts, in Marion County, Oregon, and running thence - - - South along the West line of said lot 710.82 feet to the Southwest corner of said lot; thence Easterly along the South line of said lot, 295 feet to the section line; thence North along the Section line 710.82 feet to the North line of said lot; thence Westerly along the North line of said lot 298.62 feet to the place of beginning, and containing five (5) acres of land, more or less, being the same land deeded to Joseph H. McDonald as described in Volume 199, Page 463, Deed Records for Marion County, Oregon. Save and except 52/100 of an acre described in Vol. 210, Page 301 of the Deed Records for Marion County, Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
