CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED AEBI

of Route 2, McMinnville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork Yamhill River for the purpose of

Irrigation under Permit No. 15542 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

July 12, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, NE4 SW4 & SE4 NW4, Section 10, Township 4 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.4 acres in the SN; NE, as projected on Chas. S. Tustin D.L.C. 45 5.4 acres in the SE, NW, as projected on Chas. S. Tustin D.L.C.45 Section 10 T. 4 S., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at the SE corner of the Donation Lend Claim of Charles S. Tustin and Mary J. Tustin, his wife, Claim No. 45, situate in Sections 10 and 3, Township 4 South, Renge 4 West of the Willamette Meridian, Yamhill County, Oregon; thence W. along the S. line of said Donation Land Claim, 28 chains to the line dividing the lands of Mary J. Tustin and John B.
