CERTIFICATE OF WATER RIGHT

This Is to Certify, That. ROY V. MARTIN

of Route 1, Box 305, Medford , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of old mining tunnel and Martin reservoir to be constructed under Permit No. R-346 a tributary of Griffin Creek Watershed for the purpose of Supplemental Irrigation under Permit No. 17066 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 24, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, Section 33, Township 37 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre; irrigated from direct flow and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year from direct flow and storage from reservoir to be constructed under Permit No. R-846,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8 acres in the SW_2^1 SW_3^1 Section 33 T. 37 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at the Northwest Corner Donation Land Claim No. 95 on the line between Sections 32 and 33 in Township 37 South Range 2 West, W.M. running thence South 20.84 chs; thence East 31.75 chains; thence North 37° East 6.18 chains; thence North 45° West 22.3 chains; thence West to the place of beginning, cont. 60.75 acres.

ALSO Beginning at a point 20.84 chains South of the Northwest Corner Donation Land Claim No. 95 on the line between Sections 32 and 33, Township 37 South Range 2 West, W. M.; thence East 31.75 chains; thence South 37° West 13.07 chains; thence North 69½° West 5.93 chains; thence South 74½° West 20.60 chains; thence North 13.90 chains to the place of beginning.

EXCEPTING AND RESERVING from the said above described premises the following described tract of land; to-wit: Beginning at the Northeast corner of the first above described tract of land and running thence South 37° West 20 chains; thence North 77° West 5.43° chains; thence South 74½° West 13.66 chains; thence North 37° East 34.98 chains; thence South 42½° East 15.74 chains to the place of beginning, being in the aforesaid County and State.
