CERTIFICATE OF WATER RIGHT

This Is to Certify, That **Geo. E. MAC GINITIE**

of Route 2, Box 140, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Teal Creek a tributary of Luckiamute River for the purpose of Irrigation under Permit No. 14599 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 23, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.075 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 27, Township 8 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D. L. C. 46
3.0 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on D. L. C. 46
Section 27
T. 8 S., R. 6 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:
Beginning at a point 22.85 chains East and 3.00 chains North from the Southwest corner of the Donation Land Claim of Adam Brown and wife, Claim No. 46, in Township 8 South of Range 6 West of the Willamette Meridian, in Polk County, Oregon, thence running North 40.65 chains; thence East 1.07 chains; thence North 11.80 chains; thence North 37° 30' West 19.66 chains; thence South 32° West 4.68 chains; thence South 27° 00' chains; thence East 8.00 chains; thence South 34.32 chains, to the County Road; thence Southerly along said Road to the place of beginning and containing 71 acres of land more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
