CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEO. E. MAC GINTIE

of Route 2, Box 140, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Teal Creek, a tributary of Little Luckiamute River for the purpose of Irrigation under Permit No. 14616 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 13, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$ and NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 27, Township 8 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on D. L. C. 46
5.0 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on D. L. C. 46
9.7 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D. L. C. 46

T. 8 S., R. 6 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:
Beginning at the Southwest corner of the Frederick Waymire Donation Land Claim, Notification Number 5167, Claim Number 47, Section 22, in Township 8 South, Range 6 West of the Willamette Meridian, in Polk County, Oregon, and running thence West 1.03 chains; thence South 35.55 chains; thence East 35 chains to the West boundary line of the A. E. Hedine premises, which is 1.00 chains East of the Northwest corner of the Bowman tract of 12.88 acres; thence North 0° 10' East 12.30 chains to an angle in the Hedine boundary line; thence North 87° 30' West 7.39 chains, thence West 2.63 chains to the most Westerly Southwest corner of the Hedine property; thence North 22.51 chains to the most Westerly Northwest corner of the Hedine property; thence East 5.00 chains; thence South 66° 30' East 2.08 chains; thence North 1.42 chains to the North boundary line of the Adam Brown and wife Donation Land Claim, Notification Number 5158, Claim Number 46, in Township 8 South, Range 6 West of the Willamette Meridian, in Polk County, Oregon; thence West along said boundary line 10.74 chains to the place of beginning and containing 33.5 acres, more or less.

Beginning at a point 1.72 chains East and 43.05 chains North of the Southwest corner of the Adam Brown Donation Land Claim, Notification Number 5158, Claim Number 46, in Township 8 South, Range 6 West of the Willamette Meridian, in Polk County, Oregon, and running thence West 4.98 chains to a fence on the East of Teal Creek; thence along said fence South $14^{\circ} 10'$ East 2.45 chains; thence South $24^{\circ} 0'$ East 3.02 chains; thence South $56^{\circ} 30'$ East 2.57 chains; thence South $8^{\circ} 20'$ East 1.37 chains and South $30^{\circ} 0'$ East 96 links to an anchor post on the East fence of Schlemmer; and thence North 8.05 chains to the place of beginning and containing 2.61 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
