## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That R. E. McMANUS AND ABBIE L. McMANUS

of Route 1, Gold Hill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Foots Creek

a tributary of Rogue River mining

for the purpose of

under Permit No. 15054 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 18, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.67 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SE_4^{\frac{1}{4}}$   $SE_4^{\frac{1}{4}}$ , Section 2, Township 37 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ---- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

That portion of the Southeast Quarter of the Southeast Quarter of Section 2, Township 37 South, Range 4 West of the Willamette Meridian, described as follows; Beginning at a post numbered 1, which is the section corner common to Sections 1, 2, 11 and 12 of said Township 37 South, thence going a distance of 669.8 feet more or less on a course approximately North 03' East to a post numbered 2, which is the Southwest corner of the North Half of the Southwest Quarter of said Section 1 of Township 37 South, which parcel is the placer Claim now held and operated by Robert McManus; thence going a distance of 669.8 feet more or less on a course Approximately North 03' East to a post numbered 3, which is the Northwest corner of the said McManus placer claim; thence going a distance of 396.5 feet more or less on a course approximately South 62 degrees 26' West to a post numbered 4; thence going a distance of 474.5 feet more or less on a course approximately South 66 degrees 13' West to a post numbered 5, which is on the North edge of the County Road on the left Fork of Foots Creak; thence going a distance of 475.8 feet more or less on a Course approximately South 47 degrees 23' East along the Northly edge of said

County Road to a post numbered 6; thence crossing said County Road, and going a distance of 336.16 feet more or less on a course approximately South 23 degrees 22' East to a post numbered 7; thence going a distance of 419.05 feet more or less on a course approximately South 43 degrees 10' East to the post numbered 1, the place of beginning. The above described premises containing in all 11.54 acres, more or less, bu' said premises being subject to any prior road right-of-way by virtue of asement, dedication or usage, and all being situated in Jackson County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place  $\dots$  use herein described.
