## CERTIFICATE OF WATER RIGHT

## This Is to Certify, that MRS. JAMES W. MOTT

of Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unpamed Stream

a tributary of Willamette River

for the purpose of

Irrigation and maintenance of Swimming Pool under Permit No. 15129 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 23, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, being 0.01 c.f.s. for irrigation and 0.01 c.f.s. for swimming pool,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW NW , Section 36, Township 6 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-rightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in the SWA NWA
Maintenance of Pool in the SWA NWA
Section 36
T. 6 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

The East thirty-three (33) acres of the following described tract, said 33 acres to be set off by a line drawn North and South across said tract and being the East 33 acres of the grantor's 114.65 acre farm, which farm is particularly described as follows:

Beginning at the Southwest corner of the Donation Land Claim of Elias Robbins and wife, Notification No. 248, Claim No. 49 in Township No. Six (6) South of Range No. Four (4) West of the Willamette Meridian in the County of Polk and State of Oregon, and running thence North 23.85 chains to a post; thence South 89° 35' East 53.65 chains to a post; thence South 7.02 chains to the Northeast corner of the school lot; thence West 5.00 chains; thence South 4.00 chains; thence East 5.00 chains; thence South 5.40 chains to the North line of the J. D. Walling Donation Land Claim; thence South 74° 30' West 27.85 chains and thence West 26.32 chains to the place of beginning containing 114.65 acres, more or less, together with an easement and right of way to lay and maintain a pipe line for the purpose of conveying water from any premises above the lands above described to and across the remainder of said 114.65 acres of the grantor, said pipe line to be at all times laid in the ground sufficiently deep as not to interfere with the cultivation of said lands and premises.
