## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That HORVAL R. DUNTON AND THEIMA M. DUNTON

of Goldroad , State of Arizona , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Rogue River a tributary of

for the purpose of

irrigation
under Permit No. 15113 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from December 7, 1912

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.81 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SE4, Section 13, Township 36 South, Range 7 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $\frac{1}{12}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in the NV4 NE2,
5.0 acres in the SV4 NE4,
16.0 acres in the NE4 NV4,
6.0 acres in the NV4 NV4,
10.0 acres in the SV4 NV4,
25.0 acres in the SE2 NV4,
Section 13, T. 36 S., R. 7 W., W. M.

land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

The  $NV_4^{\frac{1}{4}}NV_4^{\frac{1}{4}}$ , and all that part of the  $SV_4^{\frac{1}{4}}$   $NN_4^{\frac{1}{4}}$  lying North of Rogue River sometimes known as Government Lot 9, Section 13, Township 36 South, Range 7 West of Willamette Meridian, in Josephine County, Oregon;

Also, the NE $\frac{1}{4}$  NW $\frac{1}{4}$  and the SE $\frac{1}{4}$  NW $\frac{1}{4}$  lying North of Rogue River; and a strip of land 280 feet wide lying East of the center of Section 13, and extending to Rogue River, in what would be the SW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 13; and the NW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 13, said Township and Range.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
