**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** . FRANK WHEELER AND HELEN WHEELER

of Route 1, Box 207, Rogue River, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork and South Fork of Frys Gulch a tributary of Pleasant Creek, tributary of Evans Creek for the purpose of irrigation and domestic under Permit No. 15493 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 24, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.035 cubic foot per second, being 0.025 c.f.s. from North Fork for irrigation and 0.01 c.f.s. from South Fork for domestic,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 14, Township 34 South, Range 4 West, W. M.,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2 acres and domestic in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ ,  
Section 14,  
T. 34 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at the S.E. corner of the S.W. quarter of the N.E. quarter of the said section, and running thence North to the N.E. corner of the S.W. quarter of the N.E. quarter of said section, and running thence west along the North line of the said S.W. quarter of the N.E. quarter, 255 feet or more or less to the center of the creek, thence southwesterly along the center line of said creek to the south line of the N.E. quarter of said section, thence east 835 feet more or less, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
