CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That WILLIAM A. COUGHANOUR of Payette State of Idaho has a right to the use of the waters of Anthony Creek, a tributary of North Powder River,

for the purpose of the irrigation of 1148 acres of land and domestic and stock use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 3, at page 252 ; that the priority of the right hereby confirmed dates from the year 1880 for the irrigation of 800 acres, and from 1900 for 348 acres;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 17.94 sec. ft. from March 1st to July 1st, and 14.55 sec. ft. from July 1st to October 1st of each year; the total quantity diverted during each irrigation season not to exceed 2,870 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

40 acres in NE 1/4 of NE 1/4; 28 1/2 acres in NW 1/4 of NE 1/4; 40 acres in SW 1/4 of NE 1/4; 37 acres in SE 1/4 of NE 1/4; 16 acres in NE 1/4 of NW 1/4; 7 acres in SW 1/4 of NW 1/4; 39 acres in SE 1/4 of NW 1/4; 17 1/2 acres in NE 1/4 of SW 1/4; 39 acres in NE 1/4 of SE 1/4; 21 acres in NW 1/4 of SE 1/4; 3 acres in SE 1/4 of SE 1/4; Section Nineteen (19): 80 acres in E 1/2 of NE 1/4; 33 acres in NW 1/4 of NE 1/4; 40 acres in SW 1/4 of NE 1/4; 29 1/2 acres in NE 1/4 of NW 1/4; 40 acres in NW 1/4 of NW 1/4; 60 acres in S 1/2 of NW 1/4; 29 acres in NE 1/4 of SW 1/4; 7 1/2 acres in NW 1/4 of SW 1/4; 80 acres in N 1/2 of SE 1/4; 1 acre in SW 1/4 of SE 1/4; 13 acres in SE 1/4 of SE 1/4; Section Twenty (20): 160 acres in NE 1/4; 80 acres in N 1/2 of NW 1/4; 40 acres in SE 1/4 of NW 1/4; 27 acres in SW 1/4 of NW 1/4; Section Twenty-one (21): 80 acres in W 1/2 of NW 1/4; 40 acres in NW 1/4 of SW 1/4; Section Twenty-two (22) Township Six (6) South Range Thirty-nine (39) East of Willamette Meridian, in Union County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
