## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That ED NORMAN

0.18 cubic foot per second;

, has made proof State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Deer Creek a tributary of for the purpose of Illinois River irrigation under Permit No. of the State Engineer, and that said right to the use of said waters 15537 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 3, 1943 that the amount of water to which such right is entitled and hereby confirmed, for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEA SEA, Section 10, Township 38 South, Range 8 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated throughout the irrigation season from April 1st to November 1st of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre in the NE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, 8.3 acres in the SE<sup>1</sup>/<sub>3</sub> SE<sup>1</sup>/<sub>4</sub>, Section 10, T. 38 S., R. 8 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: All of Lot 13 in what is known as Bechtel's Subdivision of the Southeast quarter of Section 10, Township 38 South, Range 8 West of the Willamette Meridian, in Josephine County, Oregon, more particularly described as: Beginning at a point 1333 feet east of the Southwest corner of the Southeast quarter of said Section 10, thence running East 330 feet; thence North 11110 feet; thence West 330 feet; thence South 11110 feet to the place of beginning, containing 10.9 acres, more or less. Excepting there from 2.0 acres deeded to the State of Oregon by deed recorded at page 290, Volume 70 of the Deed Records of Josephine County, Oregon. (Being 2.0 acres on the southerly end of the tract)

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
