## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That LUDWIG M. AKESSON

of Route 1, Box 804, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Creek a tributary of Louse Creek, tributary of Jumpoff Joe Creek for the purpose of Irrigation

under Permit No. 15652 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 8, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 NW4, Section 28, Township 35 South, Range 5 West, V. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, subject to all existing rights, including those of the Merlin Project,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres in the SW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, Section 21, 2.5 acres in the NE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, Section 29, T. 35 S., R. 5 V., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the Southwest Corner of the Southwest one-quarter of the Southwest one-quarter of Section 21, in Township 35 South, Range 5 West of the Willamette Meridian in Oregon and running thence North 660 feet to the Northwest corner of the South one half of said legal subdivision; thence East 175 feet; thence South 660 feet to the South line of said Sec. 21; thence West 175 feet to the point of beginning, containing 2.66 acres, more or less. Also; All of the East one half of the North one half of the Northeast one quarter of the Northeast one quarter of Section 29 in Township 35 South, Range 5 West of the Willamette Meridian in Oregon containing 20 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
