## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That J. G. KNIGHT & NIDA B. KNIGHT

of La Grande , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek a tributary of Grande Ronde River for the purpose of Domestic, including irrigation of 1/2 acre domestic lawns and gardens.

under Permit No. 15840 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE1 of the SE1, Section 7, Township 3 South, Range 38 East, R. U.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to \_ \_ \_ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Commencing at the northwest corner of Lot 8, block 2, "B" street, of the town of LaGrande, Union County, Oregon seconding to the plat thereof on file in the office of the commissioner of the General Land Office at Washington D. C. running thence West 20 feet; thence north 10 feet; thence west on the center line of the alley formerly existing north of Outlot No. 1 of said town of La Grande, Oregon, 100 feet more or less, to the west bank of Mill Creek; thence southwesterly along the west bank of Mill Creek 192.6 feet, more or less, to a point directly west of a point which is 187 feet south of the northeast corner of the chicken house now standing on said tract; thence east and parallel with the north line of said Outlot No. 1 to the west end of "A" Street, at a point 182.6 feet south of the point of beginning; thence north along the east boundary line of said Outlot No. 1 and the west line of said Lot 8 of block 2 "B" Street, to the point of beginning. Being the same premises as conveyed to the grantors herein, as modified and confirmed by decree of the Circuit Court of Union County, Oregon, dated April 6, 1934 and entered in Circuit Court Journal 39 at page 96, records of said county; all in the southeast quarter of the southeast quarter of Section 7 in Township 3 South, Range 38 E. W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
