## CERTIFICATE OF WATER RIGHT

This Is to Certify, That FREDERICK A. AND ROSE DIEM

of Box 204, Merlin , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Jump-Off Joe Creek

a tributary of Rogue River , Irrigation

for the purpose of

under Permit No. 17188 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NK1 NE1 Section 20, Township 35 South, Range 6 Nest, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.0 acres in NW1 NE2 Section 20 T. 35 S., R. 6 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Commencing at the center of Section 20, Township 35 South, Range 6 West of the Willamette Meridian, said point of beginning being the Southwest corner of the Northeast Cuarter of said Section, and run thence East along the South line of said Northeast Cuarter a distance of 990 feet; thence North a distance of 1450 feet to the County Road known as the Merlin-Galice County Road; thence West along the South line of said County Road a distance of 990 feet to the West line of said Northeast Cuarter of said Section; and thence South along theWest line of said Northeast Cuarter a distance of 1550 feet to the point of beginning, containing thirty-four (34) acres, more or less, in the Northeast Cuarter of said Section.

Also, beginning at the point of intersection of the West line of said Northeast Quarter with the North line of said County Road; and run thence East along the North line of said County Road a distance of 586 feet; thence North 516 feet to the South bank of Jump-Off Joe Creek; thence following the south bank of said Creek Westerly to the intersection of said South Bank of said Creek with the West line of said Northeast Quarter, and thence South along said West line of said Northeast Cuarter 320 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
