CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLENN E. & HAROLD MENDENHALL & GUY FENDALL

of Willamina, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamina River a tributary of Yamhill River for the purpose of irrigation under Permit No. 10231 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1931

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.51 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 24, SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 25, Township 5 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.7 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$
- 16.1 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$
- 20.2 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$
- 1.3 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$
- 0.1 acre in the NE $\frac{1}{4}$ NW $\frac{1}{4}$
- 0.1 acre in the SE $\frac{1}{4}$ NW $\frac{1}{4}$
- 1.1 acres in the $\frac{1}{4}$ SE $\frac{1}{4}$

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
