of Route 3, Lebanon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hamilton Creek a tributary of South Santiam River for the purpose of irrigation

under Permit No. 11552 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 26, 1934

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA NWA, Section 20, Township 12 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres in the SE¹/₄ NE¹/₄ Section 19
0.4 acre in the SW¹/₄ NW¹/₄ Section 20
T. 12 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at an iron pipe ½ x 20 inches in the center of a County road which is on the West line of and South 18.13 chains distant from the Northwest corner of Section 12 South of Range One West of the Willamette Meridian, in Linn County, Oregon, and running thence South 69° East 5.11 chains to an iron pipe ½ x 20 inches; thence South 23 3/4° West 37.74 chains to an iron pipe 3/4 x 18 inches; thence South 23 3/4° West 1.00 chains to the South Santiam River; thence Northwesterly down the meander line of the right bank of said river to the Northwest corner of Lot 4 in Sec. 19 in said Township and range; thence E. 31.00 chains, to the Northeast corner of said Lot; thence N. 1.87 chs. to the place of beg. and containing 61 acres more or less, all lying and being in Linn County State of Oregon.

The fight to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
