CERTIFICATE OF WATER RIGHT

This Is to Certify, That M. C. FINDLEY

of Rickreall, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 12883 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 18, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.60 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 29, Township 7 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.9 acres in Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
 1.9 acres in Lot 2 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
 4.2 acres in Lot 3 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
 32.5 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at a point 8.47 chains East of the Northeast corner of the Donation Land Claim of David Goff and wife, Notification No. 113, Claim No. 45, in Township numbered Seven (7) South, Range numbered Four (4) West of the Willamette Meridian, in Polk County, Oregon, thence South 14° 30' West along the East boundary line of the right of way of the Southern Pacific Company, 48.69 chains to a point where said East boundary intersects the North boundary line of the grounds of Derry Station, thence South 75° 30' East along said North boundary line 273 links to a point, the same being the Northeast corner of said Station Grounds, thence South 14° 30' West along the East boundary line of said Station Grounds, 11.14 chains to a point, thence North 85° 43' East 44.46 chains to a point thence S. 82° 17' E. 18.13 chains to a point, thence N. 56.90 chains to a point, thence W. 50.53 chs. to the place of beginning, containing 327.19 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
