**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** RUFUS C. HOLMAN

of 712 Oregon Building, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Molalla River a tributary of Willanette River for the purpose of irrigation under Permit No. 12886 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 22, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 11, Township 5 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.8 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Chas. Cutting D.L.C. 52  
12.1 acres in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Chas. Cutting D.L.C. 52  
1.3 acres in the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Chas. Cutting D.L.C. 52  
Section 2  
T. 5 S., R. 2 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at a stone on the west line of Charles Cutting D.L.C. 52 in Sec. 2, T. 5 S., R. 2 E., W. M.; which stone is one half the distance between the northwest corner and the southwest corner of said D.L.C. 52; thence Southerly along the west line of said D.L.C. 52 a distance of 1868.56 feet to the west line State secondary Highway No. 161, a distance of 2275.7 feet to a line running east and west through the center of D.L.C. 52; thence westerly along said center line a distance of 1329.1 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
