CERTIFICATE OF WATER RIGHT

This Is to Certify, That F. E. ROVELL AND J. A. ROVELL

of Route 2, Hillsboro ,State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River

a tributary of Willamette River

. for the purpose of

irrigation under Permit No. 13877 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 7, 1939 for 0.5 c.f.s. and July 12, 1939 for 0.09 c.f.s.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW NW1), Section 14, Township 2 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 18.9 acres in Lot 1 ($NE_{\frac{1}{4}}$)

19.5 acres in the NE_4^{-1} NE_4^{-1} , as projected on D.L.C. 47

8.6 acres in Lot 2 (NW2 NE4)
Section 15,

T. 2 S., R. 2 V., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Tract I. Lot I, Section 15, T. 2 S., R. 2 W. W.M. containing 20 acres. Tract 2. Lot 2, Section 15, T. 2 S. R. 2 W. W.M. containing 8.70 acres, more or less. Tract 3. Beginning at a point 10 chains south of the northeast corner of Section 15, T. 2 S. R. 2 W. of the W.M., said point being the northeast corner of a tract of land conveyed by James G. Bennett to Nealeigh on the 9th day of August, 1909, by deed recorded on the 17th day of August, 1909, at page 409 of book 83 of the Records of Deeds of Washington County, Oregon, and running thence west 30 rods; thence south 40 rods; thence east 80 rods; thence north to the place of beginning, containing 20 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
