CERTIFICATE OF WATER RIGHT

This Is to Certify, That ED R. AND STELLA M. WILLIAMS

of Yachats , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Stream a tributary of Pacific Ocean for the purpose of

Irrigation and Domestic under Permit No. 14092 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 5, 1939, being identical with the priority of Permit No. 14086 in the name of Sadie Minton, in accordance with agreement of 7/11/39.; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second, being 0.005 c.f.s. for irrigation and 0.01 c.f.s. for domestic;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW1 SW1, Section 23, Township 14 South, Range 12 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> Domestic use in the SW SW 0.35 acre in the SW SW Section 23, T. 14 S., R. 12 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at a point in the easterly line of the R. of W. of the Oregon Coast Highway No. 101, which is south 1554.09 feet and west 34.90 feet from the 2 section corner in the west line of Sec. 23, T. 14 S., R. 12 W., W.M.; thence S. 74° 19' east 1420 feet more or less to the east line of the west of the west of Sec. 23, thence northerly on said east line of the We of the West of Section 23, 637 feet more or less to the north line of the south $\frac{1}{2}$ of the south $\frac{1}{2}$ of section 23; thence westerly on the north line of the south $\frac{1}{2}$ of the south $\frac{1}{2}$ of Section 23, 1301 feet more or less to an intersection with the easterly R. of W. line of the Oregon Coast Highway No. 101; thence South 150 41' West 252 feet more or less to the point of beginning, containing 10.21 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
