**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      ROBERT L. OWEN

of Gold Beach, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Two unnamed streams, a tributary of Rogue River for the purpose of Domestic, including irrigation of a garden not exceeding 0.3 acre in area under Permit No. 14244 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 7, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second, being 0.001 c.f.s. from west stream and 0.009 c.f.s. from east stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2, Section 10, Township 36 South, Range 14 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 2 (NW $\frac{1}{4}$  SE $\frac{1}{2}$ )

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: That certain tract of land situated in Curry County, State of Oregon, consisting of 56.75 acres, more or less, lying in Lot 1, Lot 2 and the Northeast quarter of the Southwest quarter, all in Section 10 Township 36 South, Range 14 West of the Willamette Meridian, described as follows: Beginning at an iron pipe driven on the East side of Lot 2, 1418.0 ft. South and 1255.7 feet West of the  $\frac{1}{4}$  Section corner on the East side of said Section 10; thence following the East side of said Lot 2, North 0 degrees 57' West 600 ft.; thence due West 300.0 ft; thence South 0 degrees 57' East 734.7 ft. to an iron pipe on the North bank of the Rogue River; thence South 0 degrees 57' East 100.0 ft.; thence South 83 degrees 57' West 182.2 ft; thence North 79 degrees 0' West 455.1 ft; thence North 52 degrees 3' West 460.3 ft. to the Northeast corner of Lot 3 of said Section 10; thence following the North side of said Lot 3, North 89 degrees 41' West 200.0 ft. to an iron pipe; thence North 0 degrees 43' West 325.2 ft. to an iron pipe on the North boundary of the County Road; thence North 0 degrees 43' West 988.5 ft. to an iron pipe on the North boundary of said North-east  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 10; thence South 89 degrees 46' East 200.0 ft. to an iron pipe marking the interior Section Corner of said Section 10; thence South 89 degrees 46' East 1279.7 ft. to the Northeast corner of said Lot 2; thence South 89 degrees 46' East 300.0 feet to an iron pipe; thence South 0 degrees 57' East 1306.9 ft. to an iron pipe; thence South 0 degrees 57' East 30 ft. more or

Less, to the Rogue River; thence Southwesterly, following the North Bank of the Rogue River, to a point that bears South 0 degrees 57' East 100.0 ft. more or less, from the place of beginning; thence North 0 degrees 57' West 100.0 feet, more or less, to the place of beginning; excepting from the above described tract the County Road. **SAVE AND EXCEPT:** That certain tract of land situated in County of Curry and State of Oregon, bounded and described as follows, to-wit: Beginning at an iron pipe marking the Northwest corner of Lot 2, Section 10, Township 36 South, Range 14 West, W. M.; thence North 89 deg. 46 min. West 200.0 feet to an iron pipe; thence South 0 deg. 43' East 1313.7 feet to an iron pipe on the South boundary of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of said Section 10; thence South 89 deg. 41' East 200.0 feet, thence South 52 deg. 3 min. East 190.2 feet; thence North 0 deg. 43' West 1430.7 feet; thence North 89 deg. 46 min. West 150.0 feet to the place of beginning.

**ALSO SAVE AND EXCEPT:** That certain tract of land situated in County of Curry and State of Oregon, consisting of 12.47 acres, more or less, lying in Lot 2, Section 10, Township 36 South, Range 14 West of the Willamette Meridian, in Curry County, Oregon, described as follows: Beginning at a point on the North line of said Lot 2 South 89 deg. 46 min. East 150.0 feet from an iron pipe marking the interior corner of said Section 10. Thence South 89 deg. 46 min. East 350.0 feet. Thence South 0 deg. 43 min. East 1621.2 feet. Thence North 79 deg. West 143.5 feet. Thence North 52 deg. 3 min. West 268.2 feet. Thence North 0 deg. 43 min. West 1430.3 feet to the place of beginning.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
