## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That OSCAR H. BRUCE

Mohawk , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mohawk River a tributary of McKenzie River

for the purpose of

irrigation under Permit No. 14504 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 22, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SW and SW SW SW SW SW Formship 16 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 2.0 acres in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on D.L.C. 42 0.8 acre in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on D.L.C. 43 1.0 acre in the SW: SW:, as projected on D.L.C. 43 Section 26, 0.2 acre in the NET SET, as projected on D.L.C. 39 20.2 acres in the NET SET, as projected on D.L.C. 43 9.8 acres in the SE4 SE4, as projected on D.L.C. 43 Section 27, T 16 S., R. 2 W., W. H.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at a point 2788.6 feet N. and 2103.2 feet E. of the SW Corner of the Robt. McCowan D.L.C. No. 43, Township 16 South, Range 2 West of the Willamette Meridian, said point being on the Easterly Hight of Way of the County Highway, and running thence along said Right of Way S. 35° 30' West 1263.3 feet thence S. 59° 24' East 975.2 feet, thence East 668.7 feet to the right bank of the Mohawk River, thence up said right bank 2 courses as follows: N. 57° 15' E. 173.6 feet N. 66°53' E. 121.7 feet; thence N. 153.1 feet, thence E. 193.8 feet to the said right bank of the Mohawk River, thence up said right bank N. 16° 36' E. 220.1 feet, thence N. 51°40' W. 1643.5 feet to the point of beginning, containing 39.93 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
