CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM TOWERY

of Turner , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unmamed stream formed by natural springs q tributary of North Santiam River for the purpose of

under Permit No. 11:929 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from 19, 1911

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.165 cubic foot per second;

or its equivalent in case of rotation measured at the point of diversion from the stream. The point of diversion is located in the SET NWZ, Section 25, Township 9 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.7 acres in the SEZ INZ.

3.3 acres in the NEA SWA, Section 25,

T. 9 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more expressly described by appropriator as follows: "Beginning 13.62 chains West of the Quarter Section corner between Sections 24 and 25 in Township 9 South Range 2 West of the Willamette Meridian, in Marion County, Oregon; thence South 29.64 chains; thence West 6.81 chains; thence North 29.64 chains; thence East 6.81 chains to the place of beginning, containing 20.20 acres, more or less, situated in Marion County, Oregon. Also a tract of land containing about 20.67 acres and located as follows: Commencing at the Southeast Corner of the tract above described and running along the South line of said tract West 6.81 chains to the Southwest corner of said tract; thence South 30.36 chains to the Southline of said D.L.C.; thence East 6.81 chains; thence North 30.36 chains to the place of beginning, situated in Marion County, Oregon State."

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
