**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** ROSCOE E. BRYANT

of Box 85, Mapleton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Siuslaw River for the purpose of domestic and irrigation, under Permit No. 15057 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 19, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.017 cubic foot per second, being 0.01 c.f.s. for domestic and 0.007 c.f.s. for irrigation;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 27, Township 17 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: domestic in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ ,  
0.5 acre in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ ,  
Section 27,  
T. 17 S., R. 10 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a point on the south boundary of Oregon Highway #36 south 25° 40' West 1235 feet from where the section line between sections 22 and 27 of township 17 South Range 10 West of Willamette Meridian intersects the said south boundary of Oregon Highway No. 36 and running thence south 61° 30' east 365 feet to the meander line of the Siuslaw River, thence along the meander line of said river south 40° 28' west 330.8 feet, thence north 41° west 175 feet to a point on the right bank of a creek, thence north 40° east 141 feet thence north 50° west 104 feet, to above said boundary of Oregon Highway No. 36, thence north 25° 40' east along said boundary of said highway 100 feet to the place of beginning, in Lane County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
