CERTIFICATE OF WATER RIGHT

This Is to Certify, That RUSSELL W. SCHULTZE

of 6533 S. E. 30th Avenue, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Milk Creek a tributary of Molalla River for the purpose of irrigation under Permit No. 15102 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 23, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 18, Township 4 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.3 acre in the SE 1/4 SW 1/4, Section 7,
- 1.0 acre in the NW 1/4 NE 1/4,
- 12.7 acres in the NE 1/4 NW 1/4, Section 18,
- T. 4 S., R. 2 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

—Part of the southeast quarter of the southwest quarter of section 7; and part of the north half of the northwest quarter of section 18, T. 4 S., R. 2 E. W. M., described as:

Beginning at the quarter section corner between said sections 7 and 18, thence north 73.00 feet to the middle of the county road; thence in a northwesterly direction along the center of said road 550.00 feet, more or less, to the center of another county road joining the first said county road and which said second county road runs northeasterly and southwesterly; thence southwesterly along the center of said second county road 1177.5 feet, more or less, to a point 28 rods due south of the line between said sections 7 and 18; thence West 52.00 rods; thence south 32.00 rods; thence east 12 1/2 rods to the east line of said north half of the northwest quarter of said section 18; thence north on said east line 60.00 rods to the place of beginning, containing 42.00 acres, more or less.

Situated in Clackamas County, State of Oregon.—

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
