of Cottage Grove State of , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Row River

a tributary of Willamette River

for the purpose of

irrigation under Permit No. 15202 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 10, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second;

or its equivalent in case of rotation measured at the point of diversion from the stream. The point of diversion is located in the NWA SWA and SWA SWA, Section 26, Township 20 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toons—eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: The following described real property located in Lane County, Oregon: Beginning at a point 20.15 chains N. of the SW Cor. of the Absalom Alexander Donation Land Claim #71, in Two. 20.5., R. 3 W.W.M., thence E. 19.85 chains to the center of County Road Survey No. 623, thence N. along center of said county road 30.16 chains to corner in angle of said D.L.C.
