CERTIFICATE OF WATER RIGHT

This Is to Certify, That TV. H. WOODS

of 167 Blair Street, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Spring Creek

a tributary of Curtiss Slough, a tributary of Willamette River

for the purpose of

irrigation under Permit No. 15126 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 9, 1913

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.355 cubic foot per second;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET and SWT NET, as projected, Section 2, Township 16 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such supportenant, is as follows:

0.9 acre in NE₄ NE₄,
17.5 acres in SW₄ NE₄,
10.0 acres in SE₄ NE₄,
Section 2,
T. 16 S., R. 4 W., W. M.
as projected on Chas. B. Cochran D.L.C. 52

I and on which water is to be used is a part of the property more explicitly described by appropriator as follows: PARCEL No # I

Beginning at a point 852.1 feet 2.0° 24: S. of the Northeast corner of Section 2, T.16, S.R.4 W.of the Will. Mer. in Linn County, Oregon; and running thence S. 89° 31' E. parallel to the North line of said section 745.0 feet to a point in the center line of Market Road No.2; thence along the center line of said road on a 1910.0 feet radius curve to the right (the chord of which curve bears S.8° 14! E. 601.7 feet); thence N. 89° 31' W. 2052.8 feet to the center line of a slough; thence along the center line of said slough N. 54° E. 480.0 feet, N. 77° E. 600. feet, and N. 56° E. 300. feet to the place of beginning, containing 19.91 acres.

PARCEL # 2

Beginning at a point on the West line of and S. 1°32' W. 1482.90 feet from the Northwest corner of the Charles B. Cochran D.L.C. No. 52 in T. 16 S., R. 4 W. of the Will. Mer. in Linn County, Oregon; and running thence S. 89° 31' E. parallel to the North line of D.L.C. No. 52 a distance of 1567.0 feet; thence N. 54° 00' E. 60.00 feet; thence S. 89° 31' E. parallel to the North line of D.L.C. No. 52 a distance of 2052.80 feet to the center line of Linn County Market Road No.2; thence on a 1910.0 foot radius curve to the right (the chord of which bears S.4° 01' W. 270.70 feet) a distance of 270.80 feet; thence S. 8° 05' W. along the center line of Market Road No. 2 a distance

of 224.25 feet; thence N. 89° 31' W. 3630.09 feet to the West line of D. L. C. No. 52; thence N. 1° 32' E. 456.86 feet to the place of beginning and containing 40.00 acres.

PARCEL No.#3

Beginning at a 1" rod on the West line 1320 feet N. 1° 32' E. of the Southwest corner of the Charles B. Cochran D.L.C. # 52 in T. 16 S. R. 4 W. of the Will. Mer. in Linn County, Oregon, and running thence N. 1° 32' E. along the West line of said Claim 219.84 feet to a 5/8" bolt; thence S. 89° 31' E. 3630.09 feet to the center line of Market Road No.2; thence S. 8° 05' W. along said center line 252.65 feet to a point 1320 feet North of the South line of said D.L.C.; thence N. 89° 02' W. parallel to the South line of said Claim 3600.94 feet to the place of beginning and containing 19.52 acres, situate in Linn County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
