CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. HAROLD POOLE

of Mapleton ,State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unmand stream a tributary of Siuslaw River a tributary of Siuslaw River for the purpose of domestic, including the irrigation of a garden not to exceed a acre in area under Permit No. 15471 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 10, 1913

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually ven-ricially used for said purposes, and shall not exceed 0.01 cubic foot per second;

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NWT SET, Section 9, Township 18 South, Range 10 W. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ______ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Section 9, T. 13 S., R. 10 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the quarter corner between Sections 9 and 10, Township 18, Range 10 West, running thence West on the quarter section line a distance of 28 chains, to where a piece of one inch pipe is driven into the ground, designating the starting point: From said point run South 10 chains, thence West 12 chains, thence North 10 chains and thence East 12 chains to the place of beginning, all in the Northwest Quarter of the Southwest Quarter of Section 9, Township 18, Range 10 West, containing 12 acres, more or less.

Also, starting at the beginning point above described, and run thence North 5 chains 72 links to the river bank; thence West 12 chains, thence South 6 chains 33 links, and thence East 12 chains to the place of beginning, all in Lot No. 8 of Section 9, Township 18, Range 10 West of the Willamette Meridian, all in Iane County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
