# CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** WADE NEWBIGIN

of 106 S. E. Hawthorne Blvd., Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clackamas River a tributary of Willamette River for the purpose of irrigation under Permit No. 15758 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 17, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.56 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 17, Township 2 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.4 acres in Lot 2 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ),  
18.6 acres in Lot 3 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ ),  
4.7 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ ,  
10.7 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ ,  
Section 17,  
T. 2 S., R. 3 E., W., M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the quarter section corner between Sections 17 and 20, Township 2 South, Range 3 East of the Willamette Meridian, and running thence south 1222.18 feet to the northerly line of a 24 foot road; thence following the northerly line of said road N. 86°30' east 330.3 feet to a stake at the southwest corner of the Stanley E. Semple tract; thence north 1°20' east 450 feet to a stake at the northwest corner of the Stanley E. Semple tract; thence east along the northerly line of said Semple Tract 978 feet to the westerly line of a 24 foot road; thence northerly and following the westerly line of said road to an intersection with the westerly line of Market Road No. 7; thence following the westerly line of Market Road No. 7, northerly to the north line of the Robertson tract as recorded in Book 113, page 185, deed records of Clackamas County, Oregon; thence westerly and following the northerly line of said Robertson tract to the Clackamas River; thence following the Clackamas River up stream in a southerly direction to a point which is due west 1250 feet more or less from an iron pipe which is north 685 feet from the quarter corner between sections 17 and 20 before mentioned; running thence from Clackamas River east 1250 feet more or less to an iron pipe above described; thence south 685 feet to the place of beginning, containing 100 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
