CERTIFICATE OF WATER RIGHT

This Is to Certify, That Jane N. Main

of Burns, State of Oregon, has a right to the use of the waters of East Cow Creek for Tracts No's. 1, 2 and 4, and Tract No. 3 for Cow Creek for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Harney County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 424; that the priority of the right thereby confirmed dates from Aug. 23, 1884 for Tract No. 1; 1885 for Tract No. 2; 1884 for Tract No. 3, and 1889 for Tract No. 4,

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of a cubic foot per second per acre up to April 20 of each year and shall not exceed one-sixtieth of a cubic foot per second per acre for the balance of the year; provided, that the total quantity diverted shall not exceed three acre feet per acre in any one year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
