CERTIFICATE OF WATER RIGHT

This Is to Certify, That IEE F. TEMPLE

of Pilot Rock , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of West Birch Creek

a tributary of Umatilla River

for the purpose of

irrigation
under Permit No. 12562 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from March 1, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.86 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW4 NE4, Section 23, Township 2 South, Range 31 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres in the NE NW4, 19.7 acres in the SE NW4, 9.0 acres in the NE SW4, 4.2 acres in the NW4 SW4, Section 13, T. 2 S., R. 31 E., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

The South Half of the Northwest Quarter, the North Half of the Southwest Quarter, the Northwest Quarter of the Northwest Quarter of Section 13, and;

Beginning at the Southwest corner of the Northeast Quarter of the Northwest Quarter of Section 13; thence running North 436 feet; thence East 490 feet to the center of the County Road; thence in a Southeasterly direction following the center of said County Road about 800 feet until directly East of the point of beginning; thence West about 64 rods to the point of beginning;

All in Township 2 South of Range 31 East of the Willamette Meridian in Umatilla County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
