CERTIFICATE OF WATER RIGHT

This Is to Certify, That SAMUEL A. and CLARA WEAVER

of Route 1, McMinnville, Oregon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamiill River

a tributary of Yamhill River, tributary of Willamette River for the purpose of irrigation
under Permit No. 13455 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 24. 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.345 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE4 NV4, Section 4, Township 5 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in NHZ NEZ, as projected on D.L.C. 39
7.5 acres in SWZ NEZ, as projected on D.L.C. 39
2.9 acres in SEZ NEZ, as projected on D.L.C. 39
11.9 acres in NEZ NWZ, as projected on D.L.C. 39
4.2 acres in SEZ NWZ, as projected on D.L.C. 39

Hyde Donation Land Claim; thence South 0° 11° 35° East along the West line of Henry H. Hyde Donation Land Claim for a distance of 15646 feet to a point marked by an iron pipe; thence North 89° 41° 23° East along the North line of land conveyed to Anna L. Putman by Deed recorded December 8, 1896 in Book 33 at Page 569, Deed Records for a distance of 1918.3 feet to a point in the center line of a county road marked by a 3/4° iron pipe; thence South 7° 03° 40° East along the Center of a county road for a distance of 139.92 feet to a point marked by a 3/4° iron pipe; thence North 89° 27° 51° East along the North line of land conveyed to W. A. Hawman by deed recorded March 13, 1943 in Book 121 at page 316, Deed Records, for a distance of 1871.80 feet to a point on the East line of the Henry H. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
