## CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES R. BRENTANO and BERNARD T. BRENTANO

St. Paul State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Horse Shoe Lake

a tributary of Willamette River

for the purpose of

13929 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 18, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4, Section 23, Township 4 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 3.4 acres in SE4 SN4, as projected on D.L.C. 79 20.8 acres in SW4 SW4, as projected on D.L.C. 79 Section 14, 4.6 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on D.L.C. 79 21.2 acres in NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on D.L.C. 79 10.0 acres in SW4 NW4, as projected on D.L.C. 79 Section 23,

Township 4 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 4.00 chains West of the most easterly N. E. corner of the D. L. Claim of Jean Jeangras No. 79, in T. 4. S. R. 3 W.; thence W. 13.53 chains; thence S. to the S. boundary line of said Claim 79, in the center of the St. Paul and Brentano Landing road, thence E. to a point 4.00 chains W. of the S. W. corner of said claim 79 and thence N. to the place of beginning, containing 31.77 acres, more or less.

For convenience said parcel of land is designated as lot "A".

Beginning at a point 17.53 W. of the most easterly N. E. corner of the D. L. Claim of Jean Jeangras No. 79, in T. 4 S. R. 3 W.; thence W. 11.30

chains; thence S. to the center of the above named road; thence, in a somewhat easterly course to the S. W. corner of lot "S" along the center of said road and thence N. to the place of beginning, containing 26.00 acres, more or less.

For convenience said parcel of land is designated as lot "B".

Beginning at a point 28.83 chains W. of the most easterly N. E. corner of the D. L. Claim of Jean Jeangras, No. 79, in T. 4 S. R. 3 W.; thence W. 11.30 to line between Sections 23 and 24, at the angle in the N. boundary in said claim 79; thence S. to the center of the said County road; thence in a somewhat E. course, to the S. W. corner of Lot "B" and thence No. to the place of beginning, containing 24.50 acres, more or less.

Beginning at the corner to sections 11-15-22 & 23 in T. 4 S. R. 3 W.; thence E. to the E. boundary of the W. 1/3 of the D. L. Clair of Jean Jeangras, No. 79, in T. 4 W. R. 3 W.; thence N. 11.00 chains; thence W. to the section line between sections 14 & 15 and thence'S, to the place of beginning, containing 35.26 acres, more or lest.

Beginning at the corner + sections 14-15-22 & 23 in T. 4 S. R. 3 W.; thence S. 5.77 chains to the center of way private road, used in common by me and J. E. Smith; thence in a Southerly and easterly course along the center of said road to the E. boundary line of the W. 1/3 of D. L. Claim 79; thence N. to the section line between sections 14 & 23, and thence W. to the place of beginning, containing 31, 85 acres, more or less.

Beginning at the most westerly S. W. corner of D. L. Claim of Jean Jeangras, No. 79, in T. 4 S. R. 3 W; thence E. 15.00 chains to an angle in the S. boundary of said claim 79; thence N. to the center of the Brentano-Smith private right of way; thence along the center of said private right of way to a point 5.77 chains S. of the corner to sections 14-15-22 & 23, and thence S. to the place of beginning, containing 35.97 acres, more or less.

Beginning at the most Southern S. W. corner of the D. L. Claim of Jean Jeangras, No. 79, in T. 4 S. B. 3 W.; thence N. to the center of Brentano-Smith private right of way; thence, along the center of said private right of way to the eastern boundary of the W. 1/3 of said D. L. Claim No. 79; thence S. to the S. boundary line of said D. L. Claim No. 79, and thence W. to the place of beginning, containing 48.36 acres, more or

Also the following, to-wit: Beginning at the S. E. corner of the W. 1/3 of the D. L. Claim of Jean Jeangras, No. 79, in T. 4 S. R. 3 W. thence E. 6.81 chains to 3 feet deep water at low water stage in Horse Shoe Lake; thence in a somewhat N. W. course; parallel with the meanders of said lake to the East line of said W. line of said E. 1/3 of said 79 and then S. to the place of beginning, containing 5.00 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
