CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROBERT GENE MOODY and PHYLLIS M. MOODY

of Star Route, Redmond ,State of Oregon ,has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of C.O.I. District Waste Water from the John Smith, Underwood & C. Z. Pedee Ranches a tributary of for the purpose of

irrigation and supplemental irrigation

under Permit No. 1,108 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 22, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW1 SW1, Section 5; SE1 SE1, Section 6; and NE1 NE1, Section 7, Township 15 South, Range 13 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 0.0069 of one cubic foot per second per acre, or its equivalent for each acre irrigated from May 1, to May 15, 0.0091 c.f.s. or its equivalent for each acre irrigated from May 15, to September 15, 0.0091 c.f.s. or its equivalent for each acre irrigated from May 15, to October 1, and 0.0069 c.f.s. or its equivalent for each acre irrigated from Cotober 1, to November 1, and shall be further limited to 5.45 acre feet per acre for each acre irrigated, and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to divert water from the stream from which the waste water is diverted nor the right to require the wastful use of water by others, provided further the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, conform to such reasonable rotation system as may be ordered by the proper state officer:
