CERTIFICATE OF WATER RIGHT

This Is to Certify, That OLIVER S. COLES

of 904 S. E. Lexington, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of ~~Chehalis~~ **Chehalis** Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 14157 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 2, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.41 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$ and SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 31, Township 2 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

14.2 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$
2.2 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$
1.2 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$
15.0 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Being a part of the John Marble Donation Land Claim, Not. No. 1418, Claim No. 37, in Township 2 South Range 3 West of the Willamette Meridian, in Yamhill County, Oregon, and beginning at a stake set on the West line of said Claim at a point North 22° West 17.98 chains from the Southwest corner of said Claim, from which a fir stump 30" diam. bears North 2 links and a fir 36" bears South 77° East sixteen links; thence North 22° 08' West along the West line of said claim 24.59 chains to a stake set for the Northwest corner of the South Half of said Claim, from which an oak marked "C.S.910" bears South 20° E. ten links and marked a fir 15" bears South 64° E. seven links; thence North 79° 08' East 70.50 chains to the Northeast corner of Lot 4 of County Survey No. 2494; thence South 21° 14' East 20.00 chains to the Northeast corner of Lot 5; thence following the North line of said Lot 5 and along the North line of Lot 1 on the following courses and distances, South 79° 08' West 13.34 chains; thence South 47° 50' West 17.86 chains; thence South 58° 00' West 7.85 chains; thence South 89° 27' West 4.15 chains to the Southwest corner of Lot 3; thence North 25° 17' West 12.65 chains to the Southeasterly corner of Lot 2; thence South 67° 32' West 26.68 chains to the place of beginning containing 164.33 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
