CERTIFICATE OF WATER RIGHT

This Is to Certify, That STANLEY TAYLOR

of 901 S. Hembree St., McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Chandler Creek a tributary of South Yamhill River for the purpose of irrigation under Permit No. 14872 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 17, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.006 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in Lots 4 and 5 of Block 4 of P. W. Chandler's First Addition to City of McMinnville (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 21, Township 4 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in Lots 4 and 5 Block 4 of P. W. Chandler's First Addition to the City of McMinnville, being within SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 21 T. 4 S., R. 4 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the Southeast corner of Lot Four (4) in Block Numbered Four (4) in Mrs. P. W. Chandler's Addition to the City of McMinnville in the County of Yamhill and State of Oregon; Thence running West Two and 65/100 Chains; Thence running North Four and 14/100 Chains; Thence running South 78 degrees East Three and 75/100 Chains; Thence Southerly on a curve parallel with the center line of the O & C R.R. Company's Track and Sixty feet distance therefrom Three and 14/100 Chains to place of Beginning and containing One and 16/100 acres more or less in said Addition above referred to and being known and designated on the Plat of said Addition as Lot Four (4) of Block Four (4) of said Addition. Also the following tract of land to wit: Part of Lot Five in Block Four, of said Mrs. P. W. Chandler's Addition to the City of McMinnville in Yamhill County, State of Oregon above referred to and lying immediately West of the lands above described and particularly bounded and described as follows; Beginning at the Southwest corner of said Lot Four of said Block Four of said Addition above referred to; Thence running West about Thirty Three (33) feet to fence now there on line of the "Mrs. Ollie White" lands formerly owned by Mrs. A. E. Latourette; Thence North along line of said fence to the Northeast corner of said "Mrs. Ollie White land"; Thence East to Northwest corner of said Lot Four above referred to, in said Addition above named; Thence South along West line of said Lot Four above named to place of beginning, and being a strip of land lying between said Lot Four and said "Mrs. Ollie White

land* as formerly owned by said Mrs. A. E. Letourette, in said Addition above referred to, in said City of McMinnville in Yamhill County, State of Oregon, and said premises herein above described being lands sold and conveyed to said Julia A. Seitters by J. R. Goheen and John W. Goheen, by deed bearing date November 15th 1904, which deed is duly recorded at page 363 of Volume 47 of deed records of Yamhill County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
