This Is to Certify, That ROCK ISLAND LUMBER COMPANY

of 2462 First National Bank Bldg., Saint Paul 1, Minnasota , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Sutherlin Creek North Unpqua River for the purpose of

a tributary of log pond

under Permit No. 15178 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 8, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.5 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET NWT and SET NWT, Section 20, Township 25 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - of one cubic foot per second per acre.

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

The following described property is all located in the Northwest 2; Section 20; Township 25 South; Range 5 West of the Willamette Meridian in Douglas County, Oregon:

Lot One (1) Block Two (2) of the Amended Plat of Plat "O" of the Sutherlin Land and Water Company, as surveyed, platted and recorded in the office of the County Clerk of said County,

EXCEPTING therefrom the following: Beginning at a point on the South side of Central Avenue in Lot 1 Block 2 Amended Plat of Plat "O" of the Sutherlin Land & Water Company as the same is filed and recorded in the office of the County Clerk of Douglas County, Oregon, said beginning point bears South 12° 56' East 30.0 feet and North 77° 04' East 558.56 feet distant from the stone monument which marks the Northwest corner of said Lot 1, Block 2 Plat "O" thence North 77° 04' East along the South side of Central Avenue, a distance of 250 feet to the 40' platted road; thence South 16° 04' West along West side of said road a distance of 408.55 feet, thence North 73° 56' West 218.66 feet; thence North 16° 04' East 287.35 feet to the place of beginning, and containing 1.75 acres, of land all in Lot 1, Block 2, Plat "O",

the net area of the land hereby described is 14.28 acres, more or less.

Lot Eighteen (18) of Block Two (2) Plat "O" of the Sutherlin Land and Water Company as surveyed, platted, and recorded in the office of the County Clerk of said Douglas County, Oregon, containing 12.41 acres, more or less.

Beginning at the Southeast corner of Lot Two (2) of Block Two (2), of Sutherlin Land and Water Company's Plat "O" as platted and recorded in the records of Douglas County, Oregon, and running thence Southwesterly along the Southerly boundary line of said Lot 2 to the Southwest corner of said Lot 2, and run thence Northwesterly along the Mesterly boundary line of said Lot 2, 537 feet and run thence Northeasterly on a line parallel with the southerly boundary line of said Lot 2, to the Easterly boundary line of said Lot 2, and thence Southeasterly 537 feet to the Southeast corner of said Lot 2, all situated in Douglas County, 'Oregon.

The East half of Lot Four (4) Block Two (2) of the Sutherlin Land and Water Company's Plat "O" as filed in the office of the County Clerk of Douglas County, Oregon, and described as follows: BEGINNING at an iron pipe which is South 77° 04' West, Six hundred feet (600') from the stone monument which is the Southwest corner of the Amended Plat of the Townsite of Sutherlin; thence South Twelve (12) degrees 56' East Fourteen hundred and fifty-five feet (1455') to an iron pipe, thence South 77° 04' East 150 feet to the place of beginning, containing five and Ol/100 (5.01) acres, more or less.

The East 120 feet of Lot 17, Block 2 of Plat "O" Sutherlin Land and Water Company, Douglas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
