## CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES G. GUTH, JR. and C. V. JOHNSTON

of Sunny Valley , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mackin Gulch and Grave Creek a tributary of Grave Creek, a tributary of Rogue River for the purpose of irrigation

under Permit No. 15550 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 21, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second, being 0.05 c.f.s. from Mackin Gulch and 0.22 c.f.s. from Grave Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SWL, Section 3 from Grave Creek and NEL SEL, Section 4 from Mackin Gulch, Township 34 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the North one-quarter corner of Section 9, in Township 34 South Range 6 West of the Willamette Meridian Oregon thence running East on the North line of Section 9 2537 feet to the Northwest corner of the Farleigh property thence South 854.8 feet; thence South 89° 42' West 2537 feet to the West line of the Northeast one-quarter of Section 9 thence North 854.8 feet to the point of beginning. Containing 49 acres more or less.

Lots 3 and 4 and 54.88 rods off of the South side of the Southwest one-quarter of Section 3 in Township 34 South Range 6 West of the Willamette Meridian, Oregon. Containing 80 acres more or less.
