**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** WALTER LETTY

of Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Silver Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 15685 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 28, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.038 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on John Barger, D.L.C. in Section 2, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on John Barger D.L.C.  
0.2 acre in SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on John Barger D.L.C.  
Section 2,  
Township 7 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point which is the intersection of the South line of Smith Street and the West line of South Water Street in the City of Silverton, Marion County, Oregon; running thence South 33° 50' East along the Westerly line of South Water Street 3.56 chains to the most easterly corner of the tract of land conveyed to Adda B. Van Valkenburg by deed recorded March 13, 1922 in Vol. 166, Page 224 Deed Records for Marion County, Oregon; thence S55° 30' West along the Southerly line of said Van Valkenburg Tract, 9 chains to the most Westerly corner of the tract of land conveyed to C. F. Libby by deed recorded May 10, 1883 in Vol. 30, Page 428 Deed Records for Marion County, Oregon; thence South 33° 50' East along the Westerly line of said Libby tract 5.45 chains to the center of Silver Creek; thence North 58° 30' West 6.14 chains down the center of Silver Creek; thence North 49° West 4.377 chains down the center of said Silver Creek to the point where a Westerly extension of the Southwesterly line of Lot 9, Johnson's Addition would intersect the center line of Silver Creek; thence North 56° 10' East along said extension of Lot 9 to the most Southerly corner of said Lot 9; thence South 33° 50' East along an extension of the Southwesterly line of said Lot 9, 46 feet to the Southerly line of Smith Street; thence North 55° 30' East along the Southerly line of Smith Street, 10.79 chains, more or less to the place of beginning.

Save and except any part of the above described property which may be a part of Smith Street and Madison Street in Silverton, Marion County, Oregon.

Also, Save and except, Commencing at a point 82 feet South 33° 50' East and North 55° 30' East 25 feet from the center of the intersection of Madison and Smith Streets in the City of Silverton, Marion County, Oregon, said intersection being in M. Johnson's Addition to the City of Silverton, Oregon; and running thence North 55° 30' East 165 feet; thence South 33° 50' East 59 feet; thence South 55° 30' West 165 feet; thence North 33° 50' West 59 feet to the place of beginning, located in the City of Silverton, Marion County, State Of Oregon.

Also, Save and except: Commencing at the most Northerly corner of a 4 acre tract of land conveyed by John Kilian and wife to Adda B. Van Valkenburg January 21, 1922, recorded in Vol. 166, Page 224 Deed Records for Marion County, Oregon; running thence South 55° 30' West 165 feet; thence South 33° 50' East 59 feet; thence North 55° 30' East 165 feet; thence North 33° 50' West 59 feet to the place of beginning, located in the city of Silverton, Marion County, State of Oregon.

Also, Save and except: Commencing at a point South 1189 feet, and North 33° 50' West 473 feet from the quarter section corner on the North boundary of Section 2, Township 7 South, Range 1 West of the Willamette Meridian, Marion County, Oregon; thence running North 33° 50' West 59 feet; thence South 55° 30' West 165 feet; thence South 33° 50' West 59 feet; thence North 55° 30' East 165 feet to the place of beginning, all being situated in the City of Silverton, Marion County, Oregon.

Also, Save and except: Commencing at a point South 1189.00 feet and North 30° 50' West 415.00 feet from the Quarter section corner on the North boundary line of Section 2, Township 7 South, Range 1 West of the Willamette Meridian; thence South 55° 30' West 165 feet; thence North 33° 50' West 58 feet; thence North 55° 30' East 165 feet; thence South 33° 50' East 58 feet to the place of beginning, in the City of Silverton, County of Marion, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
