This Is to Certify, that RAY W. GARLICK

of Route 1, Jefferson State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Santiam River

a tributary of Willamette River

for the purpose of

irrigation

under Permit No. 15691 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 3, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.063 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW SW as projected on Reason Roby D. L. C. 48, Section 29, Township 9 South, Range 3 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 2.6 acres in NW4 SW4, as projected on Reason Roby, D.L.C 48 1.7 acres in SW4 SW4, as projected on Reason Roby, D.L.C. 48,

> Section 29, 0.4 acre in NE SE4, as projected on Reason Roby, D.L.C. 48, in SE4 SE4, as projected on Reason Roby, D.L.C. 48, 0.3 acre

Section 30, Township 9 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Buginning at a point 10 chains North and 24.14 chains East from the Southwest corner of the Donation Land Claim of Reason Roby in Township 9 South, Range 2 West of the Willamette Meridian in Marion County, Oregon, being the Northeast corner of a ten-acre tract of land formerly owned by George Marlatt, and running thence North 7.86 chains; thence East 12.10 chains to the East line of John Myers' land; thence South along said East line 7.86 chains; thence West 12.10 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
