CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARRY RENZEIMAN

of Hebo , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Three Rivers

a tributary of Nestucca River

for the purpose of

irrigation
under Permit No. 15707 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from March 8, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.232 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the No SEA SEA, Section 11, Township 4 South, Range 10 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.6 acres in the SEA SEA,
Section 11,
7.9 acres in the SWA SWA,
Section 12,
T. 4 S., R. 10 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point south 89° 30' east 733.93 feet from the northwest corner of the southeast quarter of Section 11, Township 4 south of Range 10 west of the Willamette Meridian, running thence the following courses: South 89° 30' east 1900.9 feet along the north line of Iars Jensen claim to the northeast corner of said claim; thence south 0° 03' west along the east side of said claim 1314.73 feet to the north east corner of the school grounds; thence west along the north line of said school grounds 270 feet to the center line of the County road; thence along the center line of said county road north 37° 41' west 280.1 feet; thence north 19° 40'west 451.30 feet; thence leaving said road center line north 89° 30' west 1304.3 feet to the east line of the C. C. Jensen tract; thence north 680 feet to the place of beginning, containing 34.89 acres, more or less all in Sections 11 and 12, of Township 4 south of Range 10 west of the Willamette Meridian; Also, all of the following described property lying south of the center of Three Rivers: Beginning at the northwest corner of the southeast quarter of the southeast quarter of Section 11, Township 4 south of Range 10 west of the Willamette Meridian: thence running south 2634.49 feet along the west line of the Iars Jensen Homestead in Sections 11 and 14,

of Township 4 South of Range 10 West of the Willamette Meridian, to the southwest corner of said Homestead; thence south 89° 21° east 733.93 feet; thence north 2634.9 feet to the north boundary of said Homestead; thence north 89° 30° west 733.93 feet to the place of beginning, containing 44.4 acres more or less; the tract of land hereby conveyed containing 5 acres, more or less:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
