**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** U. S. HARKSON

of Route 2, Box 179, Sherwood, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River a tributary of \_\_\_\_\_ for the purpose of irrigation under Permit No. 15769 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 6, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 28, Township 3 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.6 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on D.L.C. 51  
0.1 acre in SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on D.L.C. 51  
Section 28,  
Township 3 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Part of the Jefferson R. Shaw and wife Donation Land Claim #51 in Sections Twenty-one, Twenty-two, Twenty-seven and Twenty-eight, Township Three South, Range One, West of the Willamette Meridian, described as:

Beginning at the meander post on line between Sections Twenty-seven and Twenty-eight, Township Three South, Range One, West of the Willamette Meridian, thence South 67° 24' West 22.71 chains, more or less, to the Southwest corner of said Donation Land Claim, thence North on Claim line 74.67 chains, more or less, to the Northwest Corner of said Donation Land Claim, thence East on Claim line 19.39 chains, thence South 10° 00' East 62.01 chains to the Willamette River, thence South 62° 00' West 10.50 chains to the place of beginning, excepting therefrom 8.12 acres, more or less, conveyed to John H. Epler in Book "Q" of Deeds at page 584, records of Clackamas County, Oregon; and except 4.00 acres, conveyed to Jewel R. Willis and Alice E. Willis, his wife, by deed recorded August 6, 1934, in book 224 of deeds at page 57,

records of Clackamas County, Oregon. The two tracts excepted being in the Southeast Corner of the said above described land.

Also, part of the John Zumwalt and wife Donation Land Claim #49 in Sections Twenty-one and Twenty-two, Township Three South, Range one West of the Willamette Meridian, described as:

Beginning at the northeast corner of said Donation Land Claim, thence west on Claim line 5.56 chains, thence South to the Willamette River, thence northeasterly along the Willamette River, 7.00 chains, more or less, to the Southwest corner of the Jefferson R. Shaw Donation Land Claim #51, and the southeast corner of the said John Zumwalt Donation Land Claim #49, thence North along Claim line 72.23 chains, more or less to the place of beginning.

Excepting from said lands, county and state roads and highways.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
