CERTIFICATE OF WATER RIGHT

This Is to Certify, That L. H. SOUTH

of Box 126, Prospect, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek, a tributary of North Fk. Rogue River, a tributary of Rogue River for the purpose of domestic for one family, including irrigation of 1/2 acre domestic garden under Permit No. 16175 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 7, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ of Section 29, Township 32 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the northwest corner of that tract heretofore conveyed to one J. G. Hibbard in Deed Record Vol. 142, page 633, Deed Records of Jackson County, Oregon, said point being 27 rods west of the northeast corner of the northeast quarter of the northwest quarter of the northeast quarter of Section 32, Township 32 S., R. 3 East, W.M.; thence south along the west line of said Hibbard tract 22.5 rods to the inside ell corner; thence west along the north line of said Hibbard tract 13 rods to the northwest corner thereof; thence north along the west line of the northeast quarter of the northwest quarter of the Northeast quarter of said Section 32, 22.5 rods to the northwest corner thereof; thence east along the north line thereof 13 rods to the point of beginning. Said property being a part of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 32, Township 32 South, Range 3 East, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
