CERTIFICATE OF WATER RIGHT

This Is to Certify, That P. L. TURNIDGE

of Route 2, Albany , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River and Wilson Lake a tributary of for the purpose of

irrigation under Permit No. 16242 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 27, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.99 cubic foot per second, being 0.50 c.f.s. from river and 0.49 c.f.s. from lake

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in them. Lot 10 (NET NET) and NWT NET, Section 24, Township 10 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.1 acres in SE4 SW4, as projected on Isaac Miller D.L.C. 72
16.1 acres in SW4 SE4, as projected on Isaac Miller D.L.C. 72
2.0 acres in Lot 7 (SE4 SE4)
18.3 acres in SE4 SE4, as projected on Isaac Miller D.L.C. 72
Section 13,
5.0 acres in Lot 10 (NE4 NE4)
20.5 acres in NE4 NE4, as projected on Isaac Miller D.L.C. 72
15.5 acres in NW4 NE4, as projected on Isaac Miller D.L.C. 72
Section 24,
Township 10 South, Fange 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the southwest corner of the Donation Land Claim of Isaac Miller, the same being Notification No. 1718 and Claim No. 72 in Township 10 South of Range & West of the Willamette Meridian, Oregon, and running thence East 31.50 chains; thence North 25.72 chains; thence West 49.40 chains to the western boundary line of said Claim; thence southeasterly following the western boundary line of said Claim to the place of beginning, containing 104.01 acres, more or less, except 12 acres out of the northwest corner of said tract heretofore sold to Melissa Govro, and containing in the tract hereby conveyed 92.01 acres, more or less, and lying and being situated in Linn County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
