CERTIFICATE OF WATER RIGHT

This Is to Certify, That M. R. MAGNESS and ARLA A. MAGNESS

of 1116 Oak Street, Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed spring a tributary of Ashland Creek Vatershed, a tributary of Bear Creek for the purpose of irrigation under Permit No. 16243 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.013 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SE_4^{\frac{1}{4}}$ NW4, Section 4, Township 39 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in SW1 NE2

Section 4, T. 39 S., R. 1 E., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Tract A. Beginning at the intersection of the south line of Nevada Street with the east line of Oak Street in the City of Ashland, Jackson County, Oregon; thence east 547½ feet on the south line of Nevada Street; thence south 113½ feet; thence west 547½ feet to the east line of Oak Street; thence northerly on the east line of Oak Street 113½ feet, more or less, to the place of beginning. Tract B. Beginning at a point in the center of Oak Street in the City of Ashland, Jackson County, Oregon 143 feet southerly from the intersection of the center line of Oak and Nevada Streets in said city; thence east parallel with Nevada Street 577 feet; thence north 143 feet to the center of Nevada Street; thence east along the center of Nevada Street 193feet; thence south 225.7 feet; thence west 193 feet; thence north 7.2 feet; thence west 577 feet, more or less to the center line of Oak Street; thence Northerly along the center line of Oak Street to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
